- 1- The Tenderer who fulfils the pre-qualification requirements as above, may participate in e-bidding process.
  - 2- The e-bids are invited in 2-bid system i.e. (i) Prequalification cum Technical Bid (ii) Financial Bid.
  - 3- Joint Ventures/consortium are permitted .
  - 4- E-tender document fee (non-refundable) and EMD shall be paid to Executive Engineer, Tenth Division , U.P. Jal Nigam, Gorakhpur through RTGS in the following bank account:
