- 1- The e-bids are invited in 2-bid system i.e. (i) Prequalification cum Technical Bid (ii) Financial Bid.
- 2- Joint Ventures/consortium are permitted.
- 3- E-tender document fee (non-refundable) and EMD shall be paid to Executive Engineer, Construction Division, U.P. Jal Nigam, Kushinagar through RTGS in the following bank account:

- 4- The validity period of the bid shall be for **120 days** after the deadline for submission or any extension thereof prescribed by the UPJN for the receipt of bids.
- 5- Conditional tenders or tenders without e-tender document fee, Earnest money deposit or invalid earnest money shall be summarily rejected.
- 6- The quantum of work can vary on either side up to any extent.
- 7- The bidders are advised to study e-bid document carefully, examine the procedures and detailed terms & conditions and its implications carefully.
- 8- U.P. Jal Nigam reserves the right to cancel e-bid or bidding process without assigning any reason thereof. The decision of UP Jal Nigam will be final and binding to all participation bidders in e-bid process.
- 9- As per latest Government order, intending bidders must produce a self declaration form executed on Rs. 100/-stamp paper without which, tender will not be accepted.
- 10- Intending Bidders must have valid PAN (Income Tax), GSTN, Character certificate issued by DM(on PWD T-4 format), Solvency certificate issued by District Magistrate (on PWD T-5 format)/ Nationalized bank of equal to or greater than value required above.
- 11- If the date of opening for specified e-Bid being declared a holiday then the date for opening of e-Bids shall be the next working day after holiday at the same time.
- 12- The Price Schedule/BOQ should be submitted / uploaded in the PDF/XLS format by the bidder electronically. The required electronic documents for fee details, qualification details, e-bid form and

technical specification details, schedules/packets to be clubbed together to make single different files for each label.

- 13- The Department shall not be liable for any delay due to the e-procurement system failure beyond its control and for any information not read by the bidders.
