
- 1.4 The quantum of work can vary on either side up to any extent. Joint Ventures/Consortium are not allowed to participate.

- 1.6 Documents to be submitted physically & uploaded along with online tender are as follows-
 - (i) Copy of RTGS/NEFT for EMD & tender fees.
 - (ii) Copy of ITR last five years.
 - (iii) Copy of Solvency certificate issued by nationalized bank.
 - (iv) Experience & performance certificates of last 10 years.
 - (v) Copy of GST/PAN certificate.
 - (vi) Copy of labour cess certificate.
 - (vii) Agreement on Rs. 100/- non judicial stamp paper (Specimen cy as given in tender documents).
